Portland Creative Business Owners and Technology Entrepreneurs Urge a 'No" Vote on Question 2

PORTLAND, Maine — More than 20 Portland creative business owners and technology entrepreneurs are urging a 'No' vote on Question 2, which will appear on the city ballot on Nov. 3.

This list includes founders and CEOs of high growth technology companies and startups, artists, and small business owners who believe that Question 2 is too broad and will put Portland's economy and jobs at risk at a time when Portland's reputation as an incubator community for creative entrepreneurs and startups is beginning to gain national attention.
